

**INSTRUMENT OF ACCEPTANCE**

WHEREAS the Republic of Cyprus has examined and approved the provisions of the Articles of Agreement of the Asian Infrastructure Investment Bank (the Articles of Agreement), dated June 29, 2015;

AND WHEREAS the Board of Governors of the Asian Infrastructure Investment Bank (the Bank) adopted Resolution No. 38, "Membership of the Republic of Cyprus" on 12 May, 2017, setting out the conditions for the admission of the Republic of Cyprus to membership in the Bank (the Resolution);

NOW THEREFORE the Republic of Cyprus HEREBY DECLARES that it accepts to be bound by the Articles of Agreement and all conditions for its membership set out in the Resolution;

The Republic of Cyprus undertakes that it will furnish evidence satisfactory to the Bank that this Instrument of Acceptance has been duly executed and deposited in accordance with its constitutional and legal requirements.

AS WITNESS this Instrument executed on the 24<sup>th</sup> day of May 2018, at Nicosia.
